WICKED CAMPERS BUYBACK TERMS & CONDITIONS



Vehicle Maintenence: All vehicles come serviced with new front break pads and new tyres. Vehicles must be serviced at a Wicked Campers repair station, or authorised Wicked repairer every 10,000km.

Registration: It is your responsibility to keep the vehicle registered. Only registered vehicles will be accepted for Buyback. This offer will be voided if vehicle registration has lapsed.

Damage: If any repairs are required to bring the vehicle back to the state at which it was originally sold, the costs of such repairs will be deducted from the buyback price. This includes damage to body panels, underbody, windows, lights, bumpers or door handles. (There is no penalty for general wear and tear or minor cosmetic damage e.g. small scratches)

Cleaning Fee: A cleaning fee of \$100 may be deducted from the buyback price if not returned in an acceptable condition.

Traffic Infringements: The purchaser will be responsible for paying any Traffic Infringement Notices (speeding, parking fines, etc) sent to Wicked Campers during your period of ownership and each notice will also result in an administration fee of \$85 to be duducted from the buyback price.

One Way Fee: You must nominate the location you wish to return the vehicle for buyback at the time of accepting this agreement. If buyback location differs from the original purchase location, up to \$700 fee will be deducted from the buyback price.

Change of Location Fee: Any changes to buyback location must be agreed to by Wicked Campers, and may incur a fee to be deducted from buyback price.

Open Option Fee: You may pay \$200 in advance (at the time of purchase) if you would like the option to nominate your buyback location at a later date. You must contact us at least 30 days prior to buyback to check available buyback locations.

Buyback Price: Your buyback price is determined by the length of the ownership period, **which must be nominated at the time of purchase.** Early return of the vehicle WILL NOT result in an increase to the buyback price, unless expressly agreed to in writing by Wicked Campers.

Returning your Vehicle for Buyback

To return your vehicle, you must phone us at least 7 days in advance to arrange a date and time. Buybacks can only be arranged between 9am - 4pm Monday to Friday.

WICKED CAMPERS SALES WARRANTY TERMS & CONDITIONS



1 Month / 1,000km Warranty: If returned to a Wicked Campers branch, we will rectify mechanical issues occuring within the first 30 days or 1,000km (whichever comes first) covering the cost of parts and labour up to the Claims Limit (see below). If you are unable or unwilling to return to vehicle to Wicked Campers, you will not be eligible for this warranty. We do not offer compensation by way of accommodation or alternative vehicles whilst the work is being completed. In the case of 4WD vehicles, this warranty does not extend to engine and gearbox cover.

Period of cover: Wicked Campers' responsibility and liability ceases once the vehicle has travelled 1000km, or once 30 days (whichever occurs first) has passed, since the date of sale. In the event that you cannot prove the exact distance travelled due to a faulty odometer or for any other reason the validity of the claim will be at the sole discretion of Wicked Campers.

Limit of Liability. The warranty covers the reasonable cost of repairs only and does not extend to any costs incurred in reconditioning or improving the vehicle or part thereof to a condition superior to that at the time of the sale.

Components Covered

Engine - Mechanical components contained within the cylinder head and block, camshaft, cam followers, push rods, rockers, rocker shafts, timing gears, sprockets, piston and piston rings, gudgeon pins, connecting rods, crankshaft, balance shafts, oil pump, oil pump drive

mechanism, distributor drive shaft or gear, timing belts or chains.

Transmissions: Manual - Mechanical parts contained within the gearbox, i.e.; gears, shafts, bearings and bushes, synchro hub and selectors,.

Transmission: Automatic - Mechanical parts contained within the casing i.e.; gears, torque converter, oil pump, shafts and bearings, valve block and govenor bands.

Specific Exclusions: Head gaskets, oil leaks, burnt or pitted valves, electrolysis, service items such as replacement oils, filters, fluids, coolant, plugs, points, fuel pump, distributor, water pump, cooling fan, viscous hubs, welsh (core) plugs.

Claims Limit: All vehicles, no matter what make, model, year, type etc are limited to a claim limit of \$1000 in total (e.g. one claim totaling \$1000 or multiple claims totaling \$1000)

Warranty Exclusions: This warranty does not cover repair or replacement of the following

- 1.) Items required by way of normal servicing and maintenance.
- 2.) Items damaged as a result of misuse, abuse or neglect of the vehicle.
- 3.) Damage as a result of the continued operation of the vehicle after a defect has occurred.
- 4.) Items fitted or repaired after the sale of the vehicle other than those repairs effected by Wicked Campers at one of its branches.
- 5.) Items damaged as a result of fire, flood, hail, theft, or deliberate act.
- 6.) Problems resulting from racing, rallying unsealed roads, or overloading of the vehicle.

NOTE: Wicked Campers shall not be liable or held responsible for any damage occurring from overheating or lack of oil or water, so please maintain your vehicle.

Claims Procedure: Call Wicked Campers on +61 417 740 308. Wicked Campers will not be responsible, liable, or make any payment for repairs commenced or incurred without the company's prior authourisation. Wicked reserves the right to direct the vehicle to it's preferred repairer. All repairs must be performed by a workshop approved by Wicked. Authorization is dependant upon a check that your particular claim is valid. An independent inspection of the vehicle may be ordered by Wicked to check the validity of the claim. If the claim is valid Wicked will, at its discretion, arrange for or give approval for an approved repairer to repair the vehicle.

Additional Warranty Conditions: This is a mechanical breakdown warranty for used vehicles, therefore a part may be worn but still quite safe and serviceable. No reimbursement shall be sought or given for work commenced without Wicked Campers' approval. Wicked shall not be liable or responsible for any damage occurring if the vehicle is left unattended or being towed. Wicked shall not be held responsible for any delays due to lack of supplies of parts or any materials needed to complete any work undertaken. The warranty is not transferable to another person or vehicle.

Overheating: We cannot stress enough the risks of continued driving if your car begins to overheat, or if it has a known cooling system problem of any ki nd. If your temperature gauge moves in a direction that is a departure from normal, stop immediately, investigate, call +61 417 740 308. Do NOT wait for it to cool and drive again as you may cause further catastrophic damage to your engine, for which you will be held liable. Driving with an inoperative temperature gauge voids all warranty coverage and may result in the hirer being held liable if overheating occurs.

Fluids & Fuels: The driver is responsible to check, at least daily and maintain all fluid levels and must immediately rectify and report to +61 417 740 308 any defect of which you become aware, however slight. Topping up a vehicle that is losing water somehow is not rectifying the problem. Rectification means a fit and proper diagnosis and repair. Wicked Campers cannot stress enough your responsibility in this regard. Continued operation of the vehicle after a defect has occurred may lead to serious consequential damage to the engine for which you will be held responsible.
